Minutes of the Amenity meeting of Thirsk Town Council held on 6th April 2000 in the Upper Room, Thirsk & Sowerby Town Hall ay 7.30pm.

Present: Cllrs Roberts, in the chair, Adamson, Jackson, Marshall, Pack, Robinson and Salmon, 1 press reporter and the clerk.

Apologies: Cllrs Hall, Morton, Murkett and Murray.

Minutes, approved at Town Council, 20th March 2000.

It was agreed to take the following 2 items before matters arising.

Town Hall, lettery application: Mrs J. Watson, a member of Thirsk & Sowerby Town Hall management committee and lottery sub committee attended the meeting to give details of the lottery application for the replacement annex. The third application has been sent off and acknowledgement has been received. It will be about 3 months before it is known if the application is successful and the estimated time for the work to be completed is 16 weeks. Mrs Watson reported that this application included more information, had been approached more professionally and help had been received from HDC. Mrs Watson was thanked for attending the meeting.

Town Council Website: Cllr Salmon explained the 3 ways which the website could be set up and maintained -1) the Town Council to do all that is involved itself (which would be very time consuming), 2) pay for someone to set up and maintain or 3) take up the offer which had been put to the Town Council by Newsquest who would use our Domain name, set up and maintain the site (at no expense to the Town Council). A design team would visit and produce designs for the pages as the Town Council wished, pages are able to be changed monthly and links from other websites in the north east could be made with Newsquest acting for us. Cllr Marshall expressed concern re legality of the proposed set up. Cllr Adamson explained that the Town Council would have pages for its own use.

Cllr Robinson arrived.

After further discussion Cllr Salmon proposed Cllr Adamson seconded "that the Town Council accept the offer from Newsquest to provide a 30 page site on the basis of proposals and following the strategy as set out by Newsquest to fund the site through the interests of commercial organisations and that this will act as a service to the community all at no cost to the Town Council", agreed unanimously. Cllr Salmon was thanked for all his time and work. Cllr Salmon to contact M/S L. Paramore, Newsquest Ltd. Working Party to be formed at next Town Council meeting.

Cllr Salmon left the meeting.

Matters Arising:

Millgate Picnic Area: Official opening to be on 13th April 2000. C Amy to bring price for including this area in his weekly inspection to the office by Monday. Cllr Marshall proposed that the area is included in the Market Place/Mill Gardens sub committee seconded Cllr Adamson, agreed. It was reported that shrubs and trees have been pulled up on the area. Town Council are to clarify who has the right to fish from the banks there.

Seats: Maintenance and painting of the seats is almost complete, only one seat left to paint, at the junction of Hambleton Drive and Long Street. Cllr Robinson expressed concern that seats which had been painted had not had a "wet paint" notice left on them.

Carrs Field, Ethel Johnson Bequest Trust: Cllr Adamson thanked the Council for the offer of fencing, post and wire so that the hedge can grow among it. Cllr Adamson reported that another dog bin is necessary in the field and that all notices that are put up are promptly removed. Cllr Marshall proposed Cllr Pack seconded that a dog bin be ordered, agreed.

Cllr Jackson asked if the rubber "chippings" which Cllr Hall had offered to the Council free of charge had been suitable for playareas; sample is to be sent to York & North Yorkshire Playing Fields Association for their comments as to suitability for use instead of wood chippings.

Correspondence:

Thirsk & Sowerby Town Hall constitution: Councillors had all received a copy for study. Various amendments were discussed and made; details to be given to Mrs Watson, Town Hall Management committee.

Letter informing the Council of a duck race at The Holmes on 9th April, noted. D. Fraser, Herriot Way: letter of complaint re rope swings in the tree on the open space opposite his house. C Amy to be asked to remove swings from stump (left when branch partially removed) and "tidy up" the stump.

An oak tree has been given to the Town Council by Mrs Bruce, 9 Millbank Court, Thirsk. It has been planted in Centenary Field; a letter of thanks to be sent to Mrs Bruce.

The Cod Beck, overflow: Cllr Adamson gave details of the recent problems, a letter of response from the Environment Agency has been received. Cllr Adamson proposed that the Town Council pursues Yorkshire Water as to why this raw sewage is coming from the overflow so regularly. (Copy to HDC Environmental Health).

Planning Application, 33 Market Place, Thirsk: Cllr Marshall proposed seconded Cllr Adamson that the Town Council inform English Heritage that the application has been made, express the concern of the Town Council that the building is in a conservation area, it is the last of its type on the Market Place and ask for it to be made a listed building. Item to included on next Town Council agenda.

Jungle Field:

Cllr Marshall reported that she had visited the area after Cllr Robinson and the clerk had found that The Cod Beck Internal Drainage Board had made numerous visits to the area. It was decided to fence the area along the roadside, C. Amy to remove branches that are unsafe on 2 willow trees and remove debris left by Drainage Board as soon as possible. Cllr Marshall proposed seconded Cllr Adamson the quote Mr C Amy had given for a post and wire fence with an access in it. It was agreed that the area should have some crack willows planted in it. Notice stating ownership to be put on fence.

Sub Committee reports:

Cllr Marshall gave a report on her visit to the following areas –

Centenary Field: Barbed wire fencing to be removed, sign stating Town Council ownership, banking needs reinforcing with more tree planting, old fence near stell needs removing and new fencing and old tree guards removing.

Whitelass: tree guards on young alders need attention.

Holmes: Fence opposite NYCC depot needs painting, sluice gate needs attention and shrub removing, public footpath sign near road needs painting, contact IDB to remove debris in beck near waterfall, more damage to footpath to Centenary Field and ash tree growing in wall near waterfall needs removing.

Cllr Robinson reported that 2 flagstones on the base of the town clock are to be replaced.

Cllr Pack gave a full report of the visit of the judges of the Yorkshire in Bloom competition. A committee has been formed to help the working party with the tasks that are to be undertaken.

Cllr Adamson asked that members of the Office sub committee see him after the meeting so that a meeting could be arranged.

Other Items of Interest and Information:

Cllr Marshall said she had been asked by Cllr Morton to have the fence repaired on St James Green. It was agreed to go ahead with seat installation on the Little Green.

Present: Clirs Adamson, in the chair, Hall, Jackson, Marshall, Morton, Murray, Pack, Roberts, Robinson and Salmon, PC Hannan, 7 members of the public, 1 press reporter, and the clerk.

Apologies: Cllr Murkett.

Police Report:

PC Hannan explained and left a letter on Thirsk Summer Community Initiative which is being organised over the 5 week period of the school holidays. The cost of the project is £2000 and to date £1000 has been raised. Cllr Salmon asked if the increase of incidents reported during the school holidays last year was due to the fact that there had not been a project. PC Hannan said that this was more than likely the reason. It was decided that the project be included on the next Town Council agenda. PC Hannan then answered general questions and before leaving the meeting gave her apologies for the next meeting. Cllr Adamson thanked PC Hannan for attending.

Suspension of Standing Orders proposed Cllr Marshall seconded Cllr Roberts, agreed.

Open Forum:

Mr P. Tate asked to speak on the planning application he and his wife have made for 33 Market Place. Cllr Salmon explained that the Town Council would be discussing the item later when Mr Tate would not be allowed to speak but the members of the public are welcome to stay to hear the opinions of the Councillors.

A parishoner raised the perrenial problem of cycling on the pavenments. Cllr Roberts felt that it was a pity that PC Hannan had left the meeting.

Another parishoner praised the mosaic on Millennium Green and asked how it was to be protected from damage, already a piece appeared to be missing. Cllr Marshall explained that in fact the mosaic was not yet finished, the piece had now been put in and the acid treatment had still to be done.

Mrs Watson, St James Green, raised the problem of the difference between her postal address and the signs stating "The Green" and asked could a sign "St James Green" be installed on The Green to solve the situation. Cllr Roberts suggested that HDC should be contacted. NYCC to be contacted re the resiting of the misleading "No entry" sign on The Green.

Mr P Tate explained various aspects of his planning application at 33 Market Place. Mr Snelling the previous owner told the meeting that his family had owned the area of the Market Place in front of the property for many years which Mrs Tate hopes to landscape with trees, seats and maybe a sculpture. Mr Tate said that it is possible that the pavement in front of the building may be moved out away from the building

however the views of NYCC will need to be sought first. Clr Marshall reminded the meeting that this application is very near to Castlegarth. Clr Hall suggested that various options for the entrance should be considered.

4 members of the public left the meeting.

Resumption of Standing Orders proposed Cllr Marshall seconded Cllr Roberts, agreed.

P1112 - NYCC and HDC to be asked again about the idea of having a place in Thirsk where the public are able to make contact with them.

P1114 - The recent removal of the hedge by Persimmon Homes on the Former Gas Works site is on the agenda of the next HDC Planning committee meeting. It was decided to send a fax to HDC expressing the views of the Town Council, asking for copies to be circulated to all planning committee members before the meeting, that planning conditions are pointless if they are not to be enforced particularly with developers who have not adhered to conditions on previous sites.

P1117 - No reply from The Cod Beck Internal Drainage Board re allowing personel to work alone in the water.

Cllr Marshall reported that street cleaning etc is now controlled by HDC Operational Services Dept.

Finkle Street car park: Problems at the moment, a letter to be sent to HDC asking for the agreed signage etc that should have been installed prior to opening, which appears to have been premature, to be carried out as soon as possible and ask when the final surface of the roadways will be applied. Concern over the large number of parking signs which have been put in Kirkgate, NYCC to be asked if so many are necessary. Cllr Salmon asked for bollards in Castlegate to prevent pavement parking.

Matters Arising:

Town Council website: Cllr Salmon reported that Newsquest are progressing with the setting up of the website. If any organisations in the area contact the Town Council repages on the website their details will be forwarded to Newsquest.

Millgate Picnic Area: Opened on 13th April 2000. Cllr Adamson suggested that the tables and seats be painted with black Ronseal in an effort to prevent graffiti. Grasscutting of the area was discussed. Cllr Robinson would like the area cut once a week. Decided that Mr Walker be contacted on Monday and asked to include with the rest of his schedule, needs cutting soon. Mr C Amy is to visit the area 3 times per week. Mr Calvert to be asked who has the right to fish there. A resident of St James Green whose property runs down to The Cod Beck has complainted to Cllr Marshall that the area is being frequented by teenagers who are abusing the tables etc. Cllr Marshall had explained that the Town Council are powerless on this and that the police should be contacted, perhaps the CCTV camera would be of help.

Seats: KTH Ltd still have to paint one seat which has been missed. Cllr Salmon reported that Inner Wheel are contemplating putting 2 seats in Castlegate. Cllr Marshall said that if seats were not allowed on Castlegate perhaps they could be put on Castlegarth which is still without any.

Carrs Field, fencing: Cllr Marshall proposed Cllr Roberts seconded that the estimate submitted by Mr C Amy be accepted for the fencing of the south side. A dog/litter bin has been ordered.

Rubber Chippings: Clir Roberts is to take more to YPFA for further testing. Town Hall Constitution: Cllr Roberts reported that it will be discussed at the next meeting of the Town Hall Management Committee which is next Monday. The Cod Beck over flow: All relevant correspondence has been copied and sent to Mr M Coates, HDC as requested. Cllr Marshall had received letters updating her on the situation re the improvement of the banking of The Cod Beck which were read to the meeting. A letter to HDC saying trees that have been removed should be replaced and no more removed; if there is any spare gravel when the beck is being cleared Carrs Field Trust would be glad of it.

Town Clock repair: Cllr Robinson expects this to be completed soon.
Yorkshire in Bloom: Cllr Marshall asked that the Library be asked to attend to their tubs. Cllr Murray reported that the Market Place was not cleaned sufficently after the market on Monday. HDC to be asked to do more.

Correspondence:

Clerk to write again to HDC re response to "A" board on The Green.

Sub Committee Reports:

Castlegarth: Cllr Marshall showed photographs of English Heritage approved boards and has 2 addresses of companies who supply them, perhaps funding could be obtained from Lottery - Grants for all and a good designer will be required to design possibly three. Cllr Adamson and Cllr Marshall looking into content and graphics.

Other items of Interest and Information:

Cllr Roberts showed a newspaper article on a person who is interested in milestones, details, photographs and OS numbers of the ones in Thirsk parish to be sent to him. Cllr Murray reported that the one at Plump Bank is in need of repair. Cllr Roberts said the one on Stockton Road also needed repairing. NYCC to be asked if Town Council can carry out necessary repairs.

Clir Marshall asked that HDC be informed of the dangerous state of the grass crete on Little Green.

Cllr Marshall asked for a letter of complaint re the nearness to the church of the new parking signs.

Thirsk Infants School Trust: Clir Marshall reported that there are no signs marking the disabled parking spaces or the "in" and "out" of the library. Clir Marshall asked if Town Council is willing to take on the small areas (grass/flowers) near the library? Clir Roberts proposed Clir Salmon seconded that they should be taken on now for a decent amount. Clir Marshall to find out the amount which is on offer. Rumours that the reference library at Northallerton is to close were reported.

Cilr Robinson asked that the grass on the grass crete near the Lord Nelson, St James Green be cut soon and that it should be cut as and when necessary. Next year the area to be included in the tenders.

Cllr Robinson asked if the Thirsk sign on Stockton Road could be moved away from the rubbish which grows around it. Mr M Roberts, NYCC to be asked if he has any objections,

Cllr Robinson suggested that a request for disc parking in Westgate be made to Sowerby Parish Council. Cllr Salmon proposed Cllr Adamson seconded that Sowerby PC be approached, agreed.
