Incorrect report in the D/S Times: Cllr Marshall was disgusted with the inaccurate and incorrect report in the recent issue of the newspaper. The matter was discussed. Cllr Robinson proposed the suspension of standing orders for 5 minutes to allow Councillors to question the reporter present, Miss A Lewis, seconded Cllr Salmon, agreed. Miss Lewis said she felt that she had reported the matter correctly and that she should have been contacted on the matter before now. # **District Council Report:**

Cur Robinson read details of HDC New Structure of Committees informing members which committees Cllrs Marshall and himself now serve on.

Details of the recent HDC Liaison meeting were reported.

Funding for regeneration, details were given on the possible way forward for Thirsk. The Hillside Ward had received Objective 2 funding of £457,000 that could be used as match funding in the Thirsk area.

At the first meeting of the new HDC cabinet on 24th May 2001 CCTV is on the agenda. Cllr Marshall had attended a meeting at which Yorkshire Forward had given details of the next steps to be made by Thirsk towards using the awarded funds, the first year has already begun, an action plan (for which £10,000 has been allocated) must be done by consultants who can have any necessary research completed by September. CIP. is still continuing for SRB money but SRB cannot be used as match funding. Planning Committee: Cllr Roberts reported that there had been 158 planning applications made during the last year (previous years had been around 100). Cllr Adamson asked in how many of these applications the decision of the Town Council and that of HDC Planning been the same? Cllr Robinson said that HDC had these details. Cllr Robinson reported that the proposed development in Picks Lane had been passed in pricipal.

Cllr Roberts introduced Ms Sanderson and Mr Allanson from The Highways Agency who had been invited to the meeting to discuss the problem of traffic noise on the A168/A19. Ms Sanderson gave a brief account of the present situation and informed the meeting that the Government had a commitment to remove the concrete surface within 10 years. Removal is scheduled to happen in approximately 5 years when normal maintenance work is due to take place. A consultation has been taking place, (Town Council have not been consulted) the result of which is to be known shortly. Resurfacing of the A168/A19 could be recommended to take place earlier but the work will certainly not be delayed beyond the normal maintenance timing. Questions from Councillors followed:

Cllr Robinson expressed concern about the 'vibration' to vehicles and the people in them; Ms Sanderson explained that roads are tested every 3 years for structural wear and there has been work done to 'ease out' the bumps at the sides of the road.

Cllrs Adamson asked had the surface worn leaving the bitumen joints proud thus causing a loud 'thump' to be heard by residents near the road as vehicles travel along the bypass? This did not seem to be the case.

Cllr Marshall is concerned that neither barriers nor trees had been installed when the road was built; also that the volume of traffic had increased greatly since the bypass had been built and would continue to do so during the next 5 years. Mr Allanson explained that trees are not good screening and do allow sound to filter through particularly if there are gaps. Cllr Jackson estimated that between ½ and ¾ of the population in Thirsk and Sowerby are

Cllr Adamson queried the expenditure on 'repairs' now and thought that surely it was more cost effective to resurface sooner? Ms Sanderson explained the method of repairing and the costs involved.

Cllr Marshall raised the problem of litter on and near the bypass and roundabouts. Ms Sanderson agreed to contact Autolink (bypass), Harcros (underneath and roundabouts) and NYCC (roads leading to bypass) asking for their co-operation in solving the problem. Cllr Roberts thanked Ms Sanderson and Mr Allanson for their helpful explanations of the situation before leaving the meeting.
